**UPS Express Critical® Fuel Surcharge**

UPS Supply Chain Solutions uses an index-based fuel surcharge for Express Critical that is adjusted monthly. The surcharge is based on an average of the daily prices of the *U.S. Gulf Coast Spot Prices for Kerosene-Type Jet Fuel* as reported by the US Department of Energy for the calendar month that is two months prior to the adjustment. Changes to the fuel surcharge are effective the first Monday of each month and are posted prior to the effective date, typically two weeks in advance. Effective October 1, 2018, the surcharge is 23.00%, based on the August *U.S. Gulf Coast Jet Fuel Price* of \$2.118 per gallon.
