**UPS Post Sales Air Fuel Surcharge**

UPS Post Sales Air uses an index-based fuel surcharge that is adjusted monthly. The surcharge is based on the *U.S. Gulf Coast prices for kerosene-type jet fuel* as reported by the U.S. Department of Energy for the month that is two months prior to the adjustment. Changes to the fuel surcharge are effective the first Monday of each month and are posted prior to the effective date, typically two weeks in advance. Effective May 6, 2019, the surcharge is 18.00%, based on the March *U.S. Gulf Coast Jet Fuel Price* of \$1.902 per gallon.
